Pacer Technology Super Glue Foam Mounting Roll (SD1) and Foam Mounting Dots (SD24) are extra-strong double stick foam products that are best used on:

- Tile
- Metal
- Glass
- Plaster
- Smooth Wood Surfaces

NOTE: Product is constructed to hold up to 1 lb. per square inch only. Do not use on wallpaper or vinyl wall coverings.

PROPERTIES:

Appearance: white foam tape (1/16" thick, 1 yard x 5/8") or dots (1/16" thick, 5/8" diameter)
Set time: 2 hours for full strength

USE INSTRUCTIONS:

1. For best results, make sure that all surfaces are clean, dry and wax-free.
2. Using a light pencil mark or other system, note exact spot where object is to be secured.
3. Cut length of Tape or select a Mounting Dot. Remove from backing paper.
4. Position product so that weight of object will be distributed evenly. Press firmly for 30 seconds. Allow 2 hours for adhesive to set.
5. For product removal: cut foam layer with knife. Remove remaining material by lifting one edge and rolling up the residue like a carpet. Once in place, product cannot be removed without damage to the adhesive.

STORAGE AND SHELF LIFE

Store in cool area. Stored under these conditions, a one-year shelf life can be expected.

SAFETY AND HANDLING PRECAUTIONS

Product considered non-toxic. In case of eye contact, flush thoroughly with water for 15 minutes. Wash hands and skin after use. Do not ingest.
