## **USE INSTRUCTIONS:**

- 1. Make sure that all surfaces are clean, dry and wax-free.
- 2. Using a light pencil mark or other system, note exact spot where object is to be secured.
- 3. Remove Foam Mounting Dot from backing paper.
- 4. Position so weight of object will be distributed evenly. Press firmly for 30 seconds.
- 5. Remove remaining protective paper and place object in exact position marked. Press firmly for 30 seconds.

CAUTION: Foam Mounting Dots are constructed to hold up to 1 pound (lb) per square inch only. Do not use product on wall paper or vinyl wall coverings.

**NOTE**: Once in place, Foam Mounting Dots cannot be removed without damage to the adhesive.

**FOR REMOVAL**: Cut Foam Mounting Dots with a knife between adhesive surfaces. Remove remaining material by lifting one edge and rolling up the residue like a carpet.
